From (196): In Sydney "he soon distinguished himself by assisting in bringing about radical reforms in the lunatic asylums of the Colony. For many years he carried on a large practice in Sydney, and became a medical authority in the first rank; so much influence did he exercise, that having, on scientific grounds, an objection to vaccination, neither the Government nor the medical profession were able to carry a compulsory law in its favour. In his later years he joined the Swedenborgians, and did much to establish and increase the New Church in Sydney. He wrote books in defence of Christianity, but his chief literary work was poetical, and as a poet he will continue to take high rank."
