Although our time is very short it is stillness and even more at times, and then the Bible is opened and I read 3 or 4 Psalms, 2 or 3 chapters and a hymn, and I can only say that generally my heart overflows with gratitude for the favour this sweet little opportunity seems to be to me, and the promise is fulfilled 'Although I have cast them far off among the brethren, and although I have scattered them among the countries, yet will I be to them as a little sanctuary in the countries where they shall come.' "

Apprenticed to a builder and contractor in London, then in business on his own.

Left England 1828 with wife and five children. Voyage of six months. Ship dismasted after leaving Cape of Good hope, then jury-rigged. Had meant to go to N.S.W., but tired of the sea by time of reaching Hobart, and struck with the beauty of Hobart's shores. In Hobart six months. Shipwrecked on the way to Swanport, proceeded in open boat. Located for a time at military settlement at Waterloo Point "in a sod hut thatched with grass" - all his belongings lost in a fire, wife and children (now six) in night attire. Francis' hand had been crushed inthe fall of a tree. Had to go 200 miles to Hobart in open boat to procure clothing and supplies. Began building a cottage. Trouble with aborigines - two of his men were speared. Francis never carried firearms, would go himself to look for stray cattle. Meeting with J.B. and G.W.W. June 1834 he was recorded as a minister by Hobart M.M. M.M. alternately in Hobart and Kelvedon till 1843. Clerk of V.D.L. Y.M.for 27 years.

Good citizen. A practical man. Member of District Roads Trust, municipal Councillor, declined request to be a J.P. (difficulty with oaths). Influence led to passing of the Affirmations Act. Helped with new Meeting House. Overwhelmed when he saw the Meeting House filled to overflowing at Isaac Sharp's lecture - "Now, Lord, let thy servant depart in peace."

terra pisé huts.

14 xi 1850 George Sanders to Jas Backhouse. Daniel Cudmore not seep, but reported to be 150 miles in the interior. Will forward books to him per sister of D.C.'s wife. (189)

James Backhouse regarded Cudmore, with Robert Cock and J.B.Hack, as a possible nucleus of a Friends Mtg. in South Aust. (155)
