These were the children of Walter, labourer, and Mary of Thorneyland, Non-M's of Carlisle, who died in 1833 and 1834. There was also a Deborah Moscrop at Ayton in 1844 from Shankil, Solport, Cumberland.

Two indictments of 7 years

- 1) for feloniously stealing from the warehouse of his employer, George Rodger, silver and cutlery manufacturer.
- 2) for embezzling from customers.

"Given a Bible in gaol, by which his conscience was awakened. Hence pleaded guilty, though 'not guilty' might have reduced his sentence to 7 years." (84)

From CON 14/3 (85) details given were: 5'6½", age 23, clerk, single, Quaker, can read and write."

J.B. (Microfilm M 698, p. 246) reports: "A.D. had made a sacrifice to principle by pleading guilty to the indictment against him." On the way out he had a more "comfortable" passage by appointment as assistant to the ship's surgeon.

Clerk to Police Office in Launceston. Scribe for a shopkeeper who gave board for his services. He had from the govt. a grant of £15 p.a. towards board plus rations. 1832 he met Backhouse and Walker at Macquarie Harbour. While prisoner in Launceston had charge of the Friends' library.

6 x 1836 assigned to J.B. in Sydney (84). "A young man of irreproachable life and exemplary piety." (M 697) "He has been a great comfort and help to us." (G.W.W. Journal, 5 iii 1837)

Jan. 1837 free pardon. Returned to Launceston.
