had been tried at the Croydon Assizes in 1788 or 9 and sentenced to 7 years.

by 1804 was free and a landholder in the Colony.

13 xii 1794 granted 30 acres in the district of Toongabbie (B.T. Box 88, p. 10)

1799 particulars given of ground cropped, stock, family.

1801 received payment for maize (A 1976 Vol. 1, p 24 B.T.Box 88, p. 45)

1804 involved in Castle Hill rebellion.

was attacked in his home, gave the alarm, and was sent to rouse help at Parramatta.

(BT Box 49 pp. 231, 4, 6. A4101 p 4. A256 p.546.)

Mrs Marsden said Joyce raised the alarm.

Owned 50 acres in Hawkesbury. (P.R.O. 59.)

1806 signed Hawkesbury settlers' address welcoming Captain Bligh, suggesting administrative improvements and stating that the act of John MacArthur in signing for the "free inhabitants" was an infringement of their rights. (Wentworth Papers. A751 pp.175, 9.)
